

## **AUTHORITY TO ACT AS CUSTOMS BROKER**

### **1. Authority - For The Purposes Of The Customs Act 1901**

For the purposes of Section 181 of the Customs Act 1901 "Act" I/we

hereby authorise IYT Pty Ltd (through its appointed Customs Broker Cable International Pty Ltd with the Corporate Customs Broker License 01970C and its nominees who are licensed customs brokers) to act as our customs broker for the purposes of the Customs Act 1901 (as amended).

### **2. Authority - For All Other Legislative Purposes**

Without limiting the generality of the appointment pursuant to Clause 1 the Company appoints IYT Pty Ltd to act on behalf of the Company for all purposes contemplated by any customs related law (as defined in the Customs Act 1901) and for any purpose required to assist with import, export or transportation of the goods of the Company.

### **3. Authority - For GST Purposes**

In addition to the Authorisation pursuant to Clause 1 of this authority, the Company further authorises IYT Pty Ltd to quote our Australian Business Number (ABN) as this may be required by the Australian Taxation Office pursuant to GST Legislation in respect of:

- a. Imported goods at the time of making the entry for home consumption Import Entry, Import Declaration or other form of reporting to the Australian Border Force and
- b. Exported goods at the time of making the Export Entry, Export Declaration or other form reporting to the Australian Border Force.

### **4. Authority for Related Purposes**

The Company authorizes IYT Pty Ltd to endorse original bills of lading and pay charges, receive commercial and operational documents such as arrival notices, shipping charge invoices, release orders or delivery orders on behalf of the Company.

## 5. Company Integrity Undertaking

The Company undertakes that as part of the Customs Act 1901, as amended, it is a requirement at all times to provide true and accurate information in relation to all aspects of international trade.

The Company acknowledges and accepts that providing false or misleading information will lead to potential Strict Liability and Absolute Liability penalties as well as Australian Border Force or Australian Customs prosecutions.

## 6. Acceptance of Standard Terms and Trading Conditions

The Company acknowledges and agrees that, by signing this Letter of Authority:

- a. we have read and understood the Standard Terms and Conditions linked here [[direct link](#)] and clause 16, which provides that the Goods are at our sole risk and that IYT Pty Ltd accepts no liability for loss of or damage to Goods regardless of the cause of such loss or damage, save in limited circumstances.
  - b. we have been advised by IYT Pty Ltd to take out insurance cover over the Goods; and
- we have authority to sign this Letter of Authority and accept its terms and conditions on behalf of the owner of the Goods.

## 7. Clause Agreements

This authorisation will commence from the date stated underneath and will remain valid until terminated (in writing) by either party.
